# The proof of identification and residence documents of the requester

1. If you are a data subject

If the document is sent without redacting Sensitive Data, the Company will redact it and it will not be deemed that the Company receiving Sensitive Data from the data subject.

### The Company's Disclaimers

The Company reserves the right to inquire for information or call for additional documents from the requester. If the information received cannot clearly show that the requester is the data subject or the agent or authorized person, the Company reserves the right to reject your request.

Any request for the exercise of the right specified above may be limited by conditions and exceptions under applicable laws. The Company may reasonably and lawfully deny your request in certain circumstances

The Company would like to inform you that if any of the following circumstances occur, the Company may reject your request to comply with the relevant laws including but not limited to:

- (1) You cannot clearly prove that you are the data subject, or has the authority to submit the request.
- (2) The request is unreasonable. For example, the requester has no right to access Personal Data, or the Company does not collect such personal data.

- (3) The request is excessive. For example, similar requests, or requests with identical content, are unreasonably and repeatedly made. The Personal Data is retained for the purpose of exercising freedom of expression, or the preparation historical documents or archives for the public interest; for research or statistical purposes, with appropriate protection measures in place to protect the rights and freedom of the data subject; or as necessary for the Company's performance of tasks carried out in the public interest or for the exercising of official authority vested in the Company; or it is sensitive personal data necessary for the performance compliance with a law to achieve the purposes of preventive medicine or occupational medicine, public interest in public health under Section 26 (5) (a) and (b) of the PDPA.
- (4) The Personal Data is retained for the establishment, compliance, exercise or defense of legal claims.
- (5) The fulfillment of the request would have adverse effects on the rights and freedom of other people.
- (6) The data processing is for compliance with a law.
- (7) The data processing is necessary for the Company's performance of public tasks, performance of duties whereby the official authority designated for the Company is exercised, and performance of its legal obligations.
- (8) The data processing is necessary for the performance of a contract to which the data subject is a party.
- (9) The data processing is necessary for legitimate interest.

In general, the requester will not be charged for fulfilling the request. However, if the request is manifestly unfounded or excessive, the Company may charge a reasonable fee for complying with such request.

Once the consideration of your request according to your rights is completed. The Company will inform you of the result and take the relevant actions within 30 days upon receipt of your request. However, depending on the complexity and the number of requests, the Company may extend this period for another 60 days in accordance with the law. The period begins and continually counts when you have provided the Company with all necessary information and documents.

Also, if you provide false information in with fraudulent intent, you may be prosecuted in accordance with the law.

#### Acknowledgment and Acceptance

I acknowledge that I have fully read and understood the content of the request and the Company's disclaimers. I affirm the integrity and precision of the provided information given to the Company. I understand that the Company may need to verify my identity to prevent unauthorized exercise of the data subject's right. Additionally, the Company may contact me for more information to process my request and to further allow the company to lawfully authorize the access, make a copy, and disclosure of the acquisition of the Personal Data obtained.

I understand that my request will not be processed until the Company has received all required information. I also understand that the Company may charge a reasonable fee for processing my request, to the extent permitted by laws, including when the request is unfounded or excessive.
