- ⁽²⁾ SSHE Management System implementation covers the Head office, Greater Bongkot North (GBN), Greater Bongkot South (GBS), Arthit (ART), S1, Suphanburi, Sinphuhom, Petroleum Development Support Base in Songkhla and Ranong (PSB and RSB), Erawan & E2FSO, Platong, Satun, Funan, Malaysia, Myanmar, and projects under PTTEP operations.
